## 4. Matters arising:

The planned public consultation has been postponed as there is still work to be done on defining the village boundary and details of the site allocations.

## 5. Review of village boundary following the proposed Built-up-Area Boundaries (BUAB) for Local Service Villages (including Loxley) issued by SDC for consultation.

Since the last meeting NP had some comments on the proposal that was agreed at the meeting. He also presented the BUAB that has been proposed by SDC. There followed some discussion regarding the purpose of defining the boundary and whether or not it should include proposed site allocations.

It was decided that in order to clarify the situation the meeting would consider the SDC proposal and raise the points of disagreement. This will be proposed to the Parish Council in order that they can submit Loxley's proposed BUAB to SDC by 28 July 2017.

Once this has been done then the focus will be on the site allocations that NP is currently working on. He will have the first one for our consideration shortly and the remainder will be done by the time of our next meeting at the end of July. ACTION: NP

The proposed BUAB from SDC was discussed and the meeting agreed that there are four areas that should be considered for change (see attached).

ACTION: NP to provide a marked up map along with detailed justification for the proposed changes. JW is to present these to the PC for approval and submission to SDC.

6. Consultation with Village re Proposed Boundary and Site Allocation

It was agreed that it is essential that we communicate with the village as to what we are doing. It was agreed that it is not practical to try and send a flyer and have drop in meetings before the school holidays so and it was decided that a on sheet summary of where we are will be produced for putting up on the village notice board and in the pub.

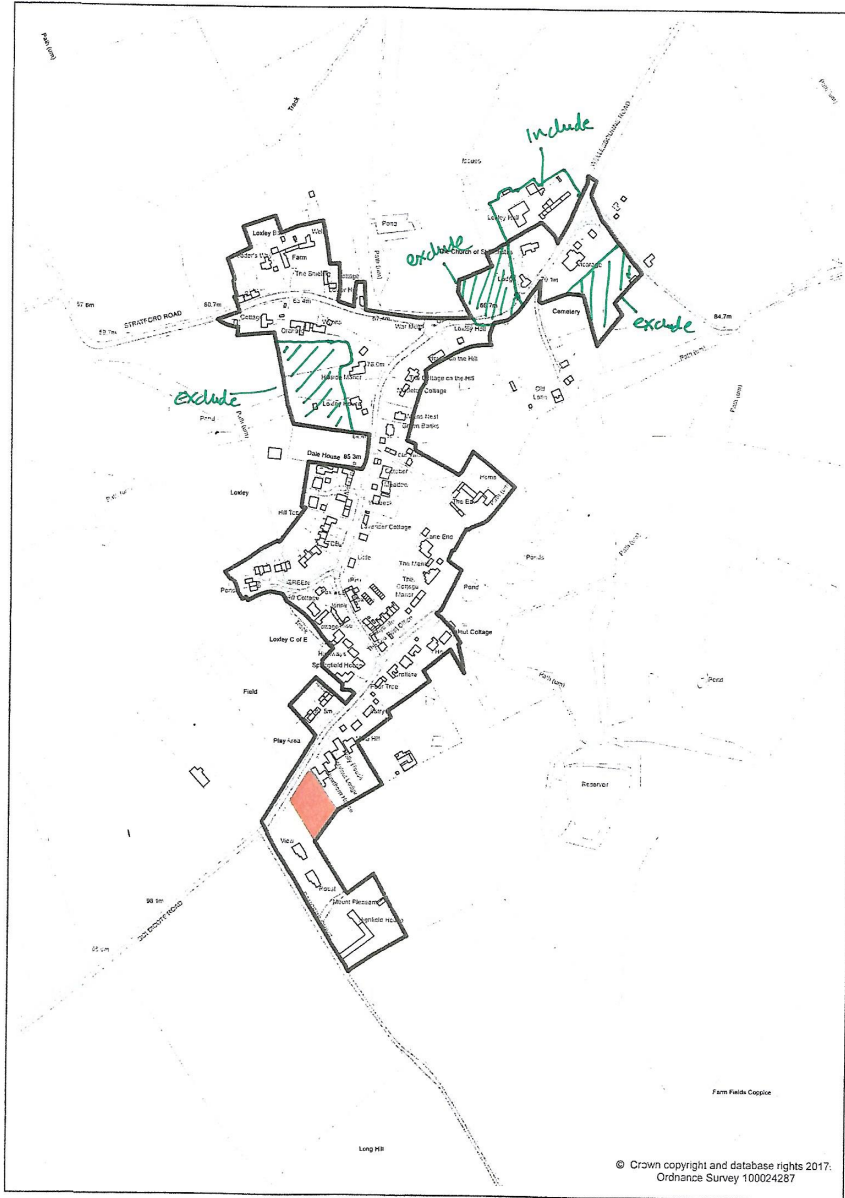
